## **PRIVACY NOTICE**

**WHY?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, information sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

**WHAT?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number.
- Account Balances.
- Credit History.
- Checking Account Information.
- Assets.
- Employment Information.

When you are no longer our customer, we continue to share your information as described in this notice.

**HOW?** All financial companies need to share customers' and members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' and members' personal information; the reasons Gunnison Savings and Loan Association chooses to share.

**WHAT WE DO:**

<b>How does Gunnison Savings and Loan protect my personal information?</b>	<b>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secure files and buildings.</b>
<b>How does Gunnison Savings and Loan collect my personal information?</b>	<b>We collect your personal information, for example, when you open an account, make a wire transfer, deposit money, apply for a loan and use your debit card.</b>
<b>Why can't I limit all information sharing?</b>	<b>Federal law gives you the right to limit only sharing for affiliates' everyday business purposes; information about your creditworthiness, to prevent affiliates from using your information to market to you and sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing.</b>

**DEFINITIONS:**

<b>Affiliates:</b>	<b>Companies related by common ownership or control. They can be financial and nonfinancial companies. Gunnison Savings and Loan has no affiliates.</b>
<b>Nonaffiliates:</b>	<b>Companies not related by common ownership or control. They can be financial and nonfinancial companies. Gunnison Savings and Loan does not share with nonaffiliates.</b>
<b>Joint Marketing;</b>	<b>A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Gunnison Savings and Loan does not jointly market.</b>
