Initial Interest Rate Discount/Premium. Your initial interest rate may be either a discounted rate or a premium rate and will not be based on the Index used to make later adjustments. Ask us for the current interest rate discount/premium under this ARM program.

HOW YOUR PAYMENTS ARE DETERMINED. Your monthly payment of principal and interest will be determined based on the interest rate, loan term, and loan balance. If your interest rate changes, your payment will be adjusted to fully amortize the loan by the end of the loan term.

Frequency of Payment Changes. Based on increases or decreases in the Index, payment amounts under this ARM program can change EVERY FIVE YEARS.

Payment Example. Your payment may increase or decrease substantially depending on changes in the interest rate. For example, on a \$10,000, 25-year loan with an initial interest rate of 8.750% (the index rate of 4.390% in effect January 2025, plus a margin of 4.000%, rounded up to the nearest .125% plus a premium of 0.250%), the maximum amount that the interest rate can rise under this program is 9.25 percentage points to 18.000%, and the monthly payment can rise from an initial payment of **\$82.21** to a maximum of **\$143.58** in the sixth year.

Note: To see what your payments would be, divide your mortgage amount by \$10,000; then multiply the monthly payment by that amount. (For example, the monthly payment for a mortgage amount of \$60,000 would be: \$60,000 divided by \$10,000 = 6; 6 X \$82.21 = \$493.26 monthly.)

Adjustment Notice. You will be notified at least 210, but no more than 240, days before the first payment at the adjusted level is due after the initial interest rate adjustment of the loan. This notice will contain information about the adjustment, including the rate, payment amount, and loan balance. You will also be notified at least 60, but no more than 120, days before the first payment at the adjusted level is due after any interest rate adjustments resulting in a corresponding payment change. This notice will contain information about the adjustment, including the interest rate, payment amount, and loan balance.
